Senators Schumer, McConnell, Wyden and Crapo:

We write to you about the need for the Senate to expeditiously consider the bipartisan Federal Disaster Tax Relief Act of 2023 (H.R. 5863). Although the Senate was unable to pass the Tax Relief for American Families and Workers Act of 2024 (H.R. 7024), millions of Americans are still in need of federal disaster tax relief. The need for this relief cannot be overstated, and that is reflected in the unprecedented discharge petition the House used to pass this legislation. This bipartisan effort was the result of 29 Republicans and 189 Democrats. After this successful discharge petition, the bill was scheduled for a vote on May 21, 2024, when it passed 382-7

This was the third successful discharge petition in the 21st century. The previous two, in 2002 and 2015, were both measures taken up by the Senate and signed into law by the President. It is our hope that the historic significance of our discharge petition on the Federal Disaster Tax Relief Act of 2023 demonstrates to the Senate the weight of its importance.

Through no fault of their own, too many Americans have incurred thousands of dollars in disaster-related expenses. Many others are also facing unfair tax burdens as a result of being heavily taxed on rightful compensation from being the victim of a wildfire disaster.

The Federal Disaster Tax Relief Act of 2023 is a comprehensive bill that includes coverage to over 300 disasters across 47 states as well as addressing both wildfire payments and the East Palestine, Ohio train derailment. This bill, and the bills precursing it, predate the Tax Relief for American Families and Workers Act of 2024 (H.R. 7024). It is the bipartisan result of representatives joining efforts to deliver disaster relief for American taxpayers after a years-long effort independent of the bipartisan tax package.

To provide some brief history on disaster tax relief initiatives:

- On January 10, 2023, Reps. Doug LaMalfa and Mike Thompson introduced H.R. 176 to exclude from gross income of a taxpayer the compensation victims receive in connection to a qualifying wildfire disaster.
- On March 1, 2023, Rep. Bill Johnson introduced H.R. 1270 to exclude from gross income the compensation resulting from the East Palestine train derailment on February 3, 2023.
- On March 1, 2023, Rep. Greg Steube introduced H.R. 1331 to treat Hurricane Ian as a qualified disaster area for purposes of the disaster-related casualty loss tax deduction.

All of our constituents know the devastating nature of disaster recovery all too well. It is our sincere hope that the Senate will take up the Federal Disaster Tax Relief of 2023 on unanimous consent to swiftly pass this bill so the President can sign it into law quickly.
